## **Generell Terms and Conditions**

### **1§ minimum turnover**

The minimum turnover (mt) of exclusive booking of the restaurant with a capacity of 110 seats is 9.000€ incl. pre-tax. for food and drinks.

The minimum turnover of the bar area with a capacity of 45 seats is 5.000€ incl. pre-tax for food and drinks.

For the whole restaurant it is 14.000€ incl. pre tax for food and drinks.

Includes food, drinks and the staff from 5pm to 3am.

All other costs you pay extra as the offer shows.

### **2§ booking conditions**

For exclusive booking or booking for 40 people up you have to pay 70% of the MT in advance.

For booking of foreign groups (EU incl. Switzerland) you have to pay 70% of the menu price in advance from 10 guests up..

We'll send you an invoice with tax for the deposit.

When we're getting this money your reservation is save.

Please pay the rest on the evening.

Unfortunately we don't make invoices on account for countries outside the EU and Denmark.

### **3§ cancellation prices**

Till 90 days before the event 25% of the deposit.

Till 60 days before the event 50% of the deposit.

Till 30 days before the event 75% of the deposit.

Under 30 days 100% of the deposit.

### **3.1.§ declaration of the Hamburg government**

If the City of Hamburg declare that the event is not allowed (f.e. Covid-19) you can change your date for free.

If you cancel you pay 700,-€ administrative charges.

### **4§ gratuity**

For an event we charge 8% gratuity for the service.

If you want to pay more let the service know.

### **5§ no shows**

In an event a reservation is showing up with less people than announced there will be a "no show" fee of 20€ per missing guest at lunch and 40€ or the price of the fix menu at dinner.
